Real Estate	\$0.10 per \$100.00 of Assessed Value
Personal Property	\$1.25 per \$100.00 of Assessed Value
Machinery and Tools	\$.20 per \$100.00 of Assessed Value
Manufactured Homes	\$.10 per \$100.00 of Assessed Value
Business Personal Property & Farm Machinery	\$.25 per \$100.00 of Assessed Value

The anticipated PPTRA Rate for calendar year 2018 is set at 50% that will be applied as credit to qualifying vehicles.
